On March 20, 2015, Tiger Media, Inc. (the "Company") domesticated as a Delaware corporation from the Cayman Islands (the "Domestication") and as a result, no longer qualifies as a foreign private issuer under the U.S. federal securities laws. After the Domestication, on March 21, 2015, the Company completed an acquisition (the "Acquisition") of The Best One, Inc. and its subsidiary, Interactive Data, LLC. The Domestication and the Acquisition are more fully described in the Company's Current Report on Form 8-K, filed with the Commission on March 26, 2015. Because of the resources required to complete the Domestication and the Acquisition, the Company could not file its Annual Report on Form 10-K by March 31, 2015 without incurring unreasonable effort and expense. The Company expects to file its annual report within the fifteen day extension period provided by Rule 12b-25.
